**LEGAL NOTICE IS HEREBY GIVEN** that at 7:30 p.m. on the 18th day of September, 2025, at the Marsing Rural Fire District Fire Station No. 1, located at 303 Main Street, Marsing, Idaho 83639, the Board of Commissioners of the Marsing Ambulance EMS District, pursuant to Idaho Code § 63-1311A, will conduct a public hearing and receive comments regarding the Board of Commissioners' intent to make a decision under "New Business" on whether or not to establish the following new Ambulance Transport and EMS Services Fees.

**2025 MARSING AMBULANCE EMS DISTRICT PUBLIC RECORDS FEES SCHEDULE**

<b>Limitation of Fees for Resident Public Records Requests:</b> Except for fees that are authorized or prescribed under other provisions of Idaho law, no fee shall be charged to residents for the first two (2) hours of labor in responding to a Public Records Requests or for copying the first one hundred (100) pages of public records requested.
<b>Prevention of Fee Evasion Through Multiple Requests:</b> If the District's custodian of the District's records has reason to believe that a requester or group of requesters is attempting to break down a request into a series of requests for the purpose of avoiding fee assessment, the Department will aggregate such requests to determine the total fee and charge accordingly.
<b>"Resident" means</b> a person whose domicile has been within Idaho continuously for a period of at least thirty (30) days, excluding a full-time student who is a resident of another state, and shall also include a domestic entity as provided in section <u>30-21-102</u> , Idaho Code. Establishment of residency shall include a spouse

and dependent children who reside with that person in the domicile. A domicile shall not be a person's workplace, vacation residence, or part-time residence.	
<b>Resident Labor Cost Fees for requests made by residents</b> shall be charged at the per hour pay rate of the lowest paid to the District's administrative staff who is the custodian of the District's Records.	
<b>Labor Cost Fees for requests made by non-residents</b> will be charged at the per hour pay rate of the lowest paid to the District's administrative staff who is the custodian of the District's Records for all hours of labor in responding to public records request.	
<b>Attorney fees</b> for public records request requiring redactions will be charged at the usual and customary rate of the District's legal counsel.	
<b>Public Records Request Fee Schedule – Copying, Transfer, and Delivery</b>	
<b>Type of Public Record Fee</b>	<b>FEE</b>
<b>Resident request Photocopying fee</b> for fewer than 100 pages on standard 8 ½ x 11 paper (no redaction required) for greater than 100 pages same as Non-resident copying fee.	No charge
<b>Non-resident Photocopying fee:</b>	\$0.10 per page (black & white); \$0.50 per page (color)
<b>Photocopying on oversized paper</b> (e.g., blueprints, maps)	Actual copying cost
<b>Requests where the District incurs out-of-pocket costs</b> to provide records	District Costs incurred
<b>Transfer of documentation to electronic or other media</b> (e.g., discs, tapes, microfilm)	District Costs incurred
<b>Mailing or shipping of copies</b>	District Costs incurred when those costs exceed \$5.00

### Authority for Setting Ambulance Transport and EMS Service Fees

1. Idaho Code § 63-1311 – Authorizes taxing districts to impose and collect fees for services provided in lieu of property tax revenue; and
  2. Idaho Code § 31-3914(8) – Authorizes ambulance service district boards to charge and collect reasonable fees for services, in accordance with §§ 63-1311 and 63-1311A.
- All interested persons are invited to attend and provide comment at the public hearing.
3. Idaho Code § 74-102 (10) authorization of public records request fees.
